STEPHAN BERNHARD HAERING OSB (Abbey of Metten), Dr. theol., Dr. iur. can. habil., M.A., born 1959, Ordinary Professor of Canon Law, in particular Administrative Law and Church Legal History, at the Klaus-Mörsdorf-Studium for Canon Law of the Ludwig-Maximilians-Universität München; Judge at the Archdiocesan Consistory and Metropolitan Tribunal Munich; Judge at the Church Labour Court Bonn; Advisor to the Ecumenical Commission of the German Bishops' Conference; Dean of the Historical Section of the Bavarian Benedictine Academy.

PIOTR KROCZEK, Catholic priest, professor of law, doctor of ecumenical theology, judge in Tribunal of Archdiocese of Cracow, chairman of the General Norms and Legal Theory Department at the Faculty of Canon Law at the Pontifical University of John Paul II in Cracow; he majored in legal theory and denominational law.

ADRIAN LORETAN-SALADIN, born 1959, studied philosophy, Catholic and Protestant theology, canon and secular law in Lucerne, Tübingen, Rome and Fribourg. Since 1996 he has been Professor for Canon Law & Law and Religion at the University of Lucerne, and was Dean of the Faculty of Theology. He has published 22 books and more than 265 articles, which have been translated into various languages. He is the editor of more than 30 books which have been published in his series *ReligionsRecht im Dialog / Law and Religion* (Münster) and *Religionsrechtliche Studien* (Zurich) and has been on the international advisory boards of the following journals: *Law and Religion* (Emory University (US), since 2016); *Philosophy and Canon Law* (Poland, since 2017); *Religion and Transforma-*

tion in Contemporary Society (University of Vienna, since 2015). MONIKA MENKE, Assistant Professor, ICLic. ThLic. Th.D., born in 1975 in Uherské Hradiště (Czech Republic, Moravia). In the years 1989—1993 she attended a secondary grammar school Uherský Brod and in 1996—2001 she studied theology in Olomouc (Czech Republic). In the year 2005 she received a Master's degree in theology and in the year 2008 doctorate, both of which majoring in canon law. In 2016 she graduated of the Faculty of Law, Canon Law and Administration at the John Paul II Catholic University of Lublin (KUL). Assistant Professor at the Palacký University in Olomouc, teaching canon law at the Faculty of Theology and State ecclesiastical law and of canon law at the Faculty of Law. Since 2001 she has been working at the Interdiocesan Tribunal in Olomouc, first as a notary, currently as a defender of the bond and Head of the Tribunal Chancery. Her academic activities include: procedural canon law (ecclesiastical justice, nullity of marriage); Teaching Office of the Church; Church management (questions of synodality and collegiality, the proportion of the laity in the exercise of judicial power); law of consecrated life. Member of the Canon Law Society (Prague), Consociatio Internationalis Studio Iuris Canonici Promovendo (Roma) and the Association of Polish Canonists (Lublin).

WILHELM REES, Dr. theol. habil, born in 1955 in Augsburg, studied Catholic Theology in Augsburg. He worked as Visiting Professor of Canon Law at the School of Catholic Theology of the University of Bamberg from 1992 to 1996. Since 1996 he is a Full Professor of Canon Law at the Theological School of the Leopold-Franzens-University, Innsbruck. He has published numerous papers on canon law, ecclesiastical law, and civil law concerning religion. He is the co-editor of the new edition of the 'German Handbook of Catholic Canon Law' (*Handbuch des katholischen Kirch-enrechts*, 2015) and the co-editor of the German scientific book series Canonistic Studies and Texts (*Kanonistische Studien und Texte*, published by Duncker & Humblot, Berlin).
