JANUSZ BALICKI, dr. hab. prof. of the Cardinal Stefan Wyszyński University in Warsaw; Institute of Political Sciences and Administration; head of the Inter-institutional Migration Research Unit and the Interdisciplinary Migration Research Network; member of the Government Population Council. Research areas: social demography; population policy; EU immigration and asylum policy

ZDZISŁAW JÓZEF KIJAS, Friar Minor Conventual (Polish). In 1990, he received his doctorate in religious sciences and dogmatics from the Catholic University of Louvain-La-Neuve (Belgium). From 1991 to 1993, he was a professor at the Catholic University of Lublin. Since 1993, at the Pontifical Theological University in Kraków. In the years 2005—2010 he held the position of Rector of the Pontifical Theological Faculty of St. Bonaventure — Seraphicum (Rome). From 2010 until 2020 he worked as a relator in the Congregation for the Causes of Saints. From 2020 the Postulator General of the Order (OFMConv).

She graduated and obtained Bachelor's and Master's degrees from the Faculty of History, Faculty of Law, and the Faculty of Theology. Since 2012 she holds a PhD in Theology, specialization Canon Law, at the Ovidius University of Constanța (Romania). Currently, she is a PhD candidate in Law, specialization Constitutional Law. She published many studies and books on canonical law and nomocanonical law, matrimonial law, constitutional law, history of law, criminal law, etc.

STANISLAV PŘIBYL, Associate Professor JUDr., Ph.D., Th.D., J.C.D., is a priest from the Catholic Archdiocese of Prague. He studied at the School of Law of Charles University in Prague and the School of Canon Law of the Institutum Utriusque Iuris of the Pontifical Lateran University in Rome. He received the degree of Associate Professor following a successful defence of his dissertation, *Tschechisches Staatskirchenrecht nach 1989* (Czech Religion Law after 1989), from the School of Law of University in Trnava (Slovakia). He is a judge soudcem and a promoter of justice of the Metropolitan Tribunal in Prague, teaches church law and secular law at the School of Theology of the University of South Bohemia in České Budějovice, and is a scientific co-worker at the Institute for Legal Aspects of Religious Freedom of the University in Trnava, as well as serves as a spiritual administrator at the St. Mary of the Assumption and Charlemagne Church in Prague-Karlovy.

PRZEMYSŁAW SAWA, presbyter of the Diocese of Bielsko-Żywiec, Doctor of Dogmatic Theology, associate professor in the Department of Dogmatic Theology and Spirituality of the Faculty of Theology, University of Silesia in Katowice, founder and director of the Cyril and Methodius School of Evangelization. His interests include ecclesiology, spirituality, theology of Church's renewal (evangelical Catholicism) and the theology of Pope Francis.

JERZY SOJKA, Ph.D. habil., professor at the Christian Theological Academy in Warsaw, head of its Department of Historical Theology.
