NICOLAE V. DURĂ, Professor, JD, born in 1945 in Romania. He obtained his Bachelor's and Master's degrees in theology from the Theological Institute of University Rank in Bucharest; followed by PhD in canon law (1981) in the same University after completing his PhD studies and research in the field of canon law in Ethiopia; doctoral and postdoctoral studies and research in France (Catholic Institute and Sorbonne University of Paris) and in Greece (Aristotelian University of Thessaloniki). In 1997 he obtained a degree of Doctor in Canon Law at the Pontifical University of Toulouse (France); and in 2002 — Doctor Honoris Causa granted by the Humanist Sciences University of Ostrog (Ukraine); 2010 — Doctor Honoris Causa — the St. Kliment Ohridski University of Sofia (Bulgaria); 2015 — Doctor Honoris Causa — the Ivane Javakhishvili State University from Tbilisi (Georgia).

Emeritus Professor of the Ovidius University of Constanța (2012—). He is a member of the following scholarly organisations: Academy of Romanian Scientists, Society of the Law of the Oriental Churches, based in Vienna; the International Consortium for Law and Religion Studies, Faculty of Law, University of Milan. Professor of Theological Institute of University Rank in Bucharest (1976—2001) and Professor of the Faculty of Law and Faculty of Theology of the Ovidius University in Constanta (2001—). Vice-Dean (for Education and Research) of the Faculty of Law, Ovidius University of Constanța (2004—2008); Vice-Rector of the Ovidius University for Inter-University Relations and Foreign Students (2008—2012). Prizes: The National Order of Merit (version of the Legion of Honour, Cultural Merit), awarded in 2001 by the President of France, Jacques Chirac, at the proposal of the Minister of External Affairs for his contribution to the promotion of the French language and European cul-

ture due to his book, amounting to more than 1,000 pages, *Le Regime de la synodalite selon la legislation canonique*, *conciliaire*, *oecumenique*, *du Ier millenaire*, published in Bucharest in 1999; A. D. Xenopol Award granted by Romanian Academy in 2001 etc. Author of books, studies and articles (on theology, canon law, law, history, ecclesiology, the history of ancient literature, philosophy etc.), amounting to thousands of pages published in different languages.

Tomasz Gałkowski CP, Professor UKSW, born in 1967, he graduated from the Pontifical Faculty of Thelogy "Bobolanum": SJ in Warsaw. In the years 1991—1995 he studied canon law at the Pontifical Gregorian University in Rome, where on the basis of the dissertation *Il quid ius nella realta umana e nella Chiesa* he received his doctoral degree. He was awarded with the Bellarmin's Prize for his publication (Analecta Gregoriana series no. 269, Roma 1996). In 2007, he received a postdoctoral degree at the Faculty of Canon Law of the Cardinal Stefan Wyszyński University in Warsaw. His monograph *Right–Duty. Priority and interdependence in the law orders: Canonical and the secular society* was awarded the Prize of the Rector of the University. He is the author of about 70 scholarly publications. His research interests include issues related to the *ratio legis* of the canonical norms and issues of common/civil law and canon law. Currently he is a professor and director of the chair of the Theory of Canon Law at this University.

Damián Němec, born in 1960 in Boskovice (Czech Republic, Moravia), his mother tongue is Czech. Dominican since 1986, ordained priest in 1991, 1998–2002 provincial of the Czech Dominican Province.

Professor at the Palacký University of Olomouc, teaching canon law and religion law at the Faculty of Theology and at the Faculty of Philosophy. Research worker on the Faculty of Law at the University of Trnava (Slovak Republic).

Translator of several official documents of the Catholic Church into Czech. Translator of liturgical texts of the Catholic Church into Czech. Member of the Canon Law Society (Prague) and its Institute of Ecclesiastical Law. Member of Consociatio Internationalis Studio Iuris Canonici Promovendo (Roma), Société International de Droit Canonique et de Législations Religieuses Comparées (Paris), International Consortium for Law and Religion Studies [ICLARS] (Milano) and The European Society for History of Law (Brno).

Jurij Popovič, ICDr., was born on 16 December 1969 in Olenevo, Ukraine (former Carpathian Ruthenia). After completing his basic theo-

logical studies in Prešov (1991—1996), he was ordained as a priest and pursued his post-graduate studies at the Pontifical Oriental Institute in Rome in the field of canon law. After completing his Licentiate study (1996–1998), he was awarded an academic degree of Licentiate of Canon Law (abbr. ICLic.). In 2010, he began his doctoral studies at the John Paul II Catholic University in Lublin, Poland. Upon completion of the PhD programme, he was awarded an academic degree of Doctor of Canon Law (abbr. ICDr.). From 2003 to 2006, he worked as a lecturer at the Faculty of Greek Catholic Theology in Prešov. From 2003 to 2007, he also served as a judge at the Diocesan Court in Prešov. In the years 2007— 2008, he held an office of a judicial vicar at the Ecclesiastical Court of the Prešov Eparchy, and in 2008—2019 he served as a judicial vicar at the Metropolitan Tribunal of the Prešov Metropolia. Currently, he is a judge at the ecclesiastical court. Since 1 October 2019, Dr. Popovič works as a lecturer at the Department of Systematic Theology at the Faculty of Greek Catholic Theology of Prešov University in Prešov. He specialises in canon law, confessional law, and Roman law. He currently works at the Department of Social Sciences and Humanities as a university associate professor.

STANISLAV PŘIBYL, Associate Professor JUDr., PhD, ThD, JCD, is a priest from the Catholic Archdiocese of Prague. He studied at the School of Law of Charles University in Prague and the School of Canon Law of the Institutum Utriusque Iuris of the Pontifical Lateran University in Rome. He received the degree of Associate Professor following a successful defence of his dissertation, *Tschechisches Staatskirchenrecht nach 1989* (Czech Religion Law after 1989), from the School of Law of University in Trnava (Slovakia).
